In consideration for the acceptance of my registration as a voluntary participant in the above entitled event, and with the understanding that my participation in this event is on the condition that I enter into this agreement, for myself, my heirs and assignees, I hereby assume the inherent and extraordinary risks involved in the BGCM Dodgeball Tournament and any risks inherent in any other activities connected with this event in which I may voluntarily participate. I expressly assume the risk of, and accept full responsibility for, any and all injuries, including death, any and all accidents which occur on the premises, and damage to or loss of personal property which may occur as a result of my participation in this event and release from liability, covenant not to sue and indemnify BGCM, City of Milford, sponsors and each of their officers, directors, agents, representatives, employees and members ("Releasees"). I understand that this Release covers liability, claims and actions caused entirely or in part by any acts or failures to act of the Releasees, including but not limited to negligence, mistake, or failure to supervise by the Releasees. I understand that I hereby waive any claim I may have hereafter against the Releasees as a result of my participation in the BGCM Dodgeball Tournament and in any other activities connected with this event in which I may voluntarily participate.

I understand that BGCM and the City of Milford will not have medical personnel available at the Dodgeball Tournament. I understand and agree that the Releasees are granted permission to authorize emergency medical treatment, if necessary. I understand and agree that Releasees assume no responsibility for any injury or damage that might arise out of or in connection with such authorized emergency medical treatment.
